- ◆ **Seek and suggest solutions**
- ◆ **Maintain confidentiality, to extent possible**
- ◆ **Advocate for your personal rights**
- ◆ **Negotiate a resolution**



It is the policy of the Ombudsman to maintain confidentiality of the information provided to the extent possible. Exceptions to this policy will be discussed with callers who will be informed that all reports of child endangerment, abuse and/or neglect must be reported by law.

Children's Group Home Ombudsman Program

The Los Angeles County Board of Supervisors established a Children's Group Home Ombudsman within the Department of Auditor-Controller. The Ombudsman's role is to be an independent advocate for children placed in group homes by the Department of Children and Family Services (DCFS).

The **Children's Group Home Ombudsman responsibilities** include:

- Maintaining a toll free telephone number (1-888-445-1234) for DCFS group home residents to call from anywhere to express their concerns and complaints.
- Providing children information on their rights when placed in a group home.
- Providing a voice to speak and act on behalf of children residing in group homes.
- Creating an avenue for children to discuss their group home concerns without fear of retaliation from their providers and/or placement workers.
- Listening to concerns, gathering relevant information, documenting complaints.
- Suggesting resolutions and offering recommendations that are reasonable and feasible.
- Working together with the County and service providers to benefit group home residents.


